Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 53.43 tCO₂e by 2029. This is a reduction of 27%

- 1. Partnership with the Woodland Trust to plant 2000 trees a year
- 2. Invest in new electric and hybrid company vehicles
- 3. Removal of all non-ULEZ compliant vehicles from fleet
- 4. LED lighting upgrade in offices
- 5. Continue the use of cargo bikes for works in Urban areas

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2023 baseline. The carbon emission reduction achieved by these schemes equate to 16.69 tCO₂e, a 27%ge reduction against the 2045 baseline and the measures will be in effect when performing the contract.

In the future we hope to implement further measures such as:

- 1. Further tree planting partnerships
- 2. Further the fleet refurbishment programme
